As always we have a few reminders for everyone to ensure everyone knows and abides by the Park rules, which contributes to a safe, relaxing stay at the Parks:

<u>Parents / Care Givers</u>: please make sure those in your care (as well as yourselves) know the park rules, especially regarding the use of push-bikes and push-scooters:

- **ONLY** push bikes and push scooters are permitted to be ridden in our Park.
- The use of eScooters, eBikes and eSkateboards, (this includes motorized too) or normal skateboards, trikes that are low to the ground, rollerblade/skates **ARE NOT PERMITTED.**
- Helmets must be worn as our roads do fall under the NSW Roads regulations.

Please inform those in your care that riding in, through and around the **AMENITIES**, **Camp kitchen and games** room is not permitted.

- All riding activity must cease when the street lights are on or between 8pm and 7am for the consideration of all park patrons.
- These are high use areas by all patrons young and old, and are for PEDESTRIAN ACCESS ONLY, hence being no go areas.



• Bikes and scooters must not be 'dropped' on the ground right at the door of said buildings as they block the entry/exit doorways to these buildings.

## **Spare Sites In Use over summer holidays**

During these busy times especially, we utilize all tourist sites including the odd sites located in amongst HV sites, so we appreciate they not be used for parking by HVO's (at any time of the year).

#### **Rabbits**

Unfortunately this is an issue that may never be resolved as we are no longer permitted to use poisoned bait to eradicate them. We do however engage an external company for our rabbit and pest control a few times per year.

Rabbits seem to prefer to be around or at least near the HV sites as the vans give them somewhere to hide.

We advise all van owners to ensure their van skirting is sufficiently solid / rabbit proof (as best possible) to discourage them making a burrow underneath. Don't forget to submit a Site Alteration request form for approval before making any changes to existing skirting materials/colours.

If you do find some big holes, please let us know and we can address the issue

## **Works on Holiday Vans during Peak**

As always (and to ensure everyones' holidays and down-time are considered), **NO WORKS** are to be conducted during the summer holidays, starting on Wednesday 20 December until Monday 29 January 2024 inclusive. For emergency works, please contact Admin Officer or PArk office.

Please, no tents, swags or paddling pools are to be set up on HV sites.

# **New Security**

We have a **new security** company on board – BSMS Security, and we will have a dedicated patrol for our parks only, during the school holidays.

Your call will be logged, triaged and dealt with accordingly. If your call relates to a noise or behavior issue of another site, you - as the caller - will **not** be charged the after hours call out fee, it would be the perpetrator who gets charged if on-call personnel have to attend. ## Electricity Meters will be read and invoiced prior to the NSW School holidays.

Daily Supply Charge - 95.70 cents / day x 180 / 4 = \$43.07/qtr

Usage Charge Rate - 37.76 cents/kWh
